

Nara Institute of Science and Technology
Affiliate Laboratory Regulations

April 1, 2006
Regulations No. 14

Article 1 (Purpose)

These regulations stipulate the necessary matters concerning the implementation of Affiliate Laboratories in the Nara Institute of Science and Technology (hereinafter referred to as “NAIST”), in accordance with article 4 paragraph 3 of the Nara Institute of Science and Technology Graduate School Academic Faculty Regulations (Regulations No. 1, 2011)

Article 2 (Affiliate Laboratory purpose)

Through collaboration with private industry and research institutions (hereinafter referred to as “Affiliate Institutions”), Affiliate Laboratories shall be established for the purpose of further expanding and developing NAIST’s educational research while promoting research exchange.

Article 3 (Laboratory titles)

The titles of Affiliate Laboratories shall express the contents of the educational research being performed at the respective Affiliate Laboratory.

Article 4 (Collaboration agreements)

1. In order to effectively carry out students’ educational research in the Affiliate Laboratories, a collaboration agreement (hereinafter referred to as “Agreement”) concerning the educational research to be performed at the Affiliate Institutions or Affiliate Laboratories shall be concluded
2. The aforementioned Agreement must be deliberated by the Faculty Council and the Education and Research Council, and then voted upon by the Board of Directors.

Article 5 (Affiliate Laboratory organization)

1. The Affiliate Laboratory shall consist of at least one member equivalent to a Professor.

2. The selection of Affiliate Laboratory faculty or staff (hereinafter referred to as "Affiliate Laboratory Staff") shall be carried out according to the NAIST selection process for specially-appointed professors.

Article 6 (Affiliate Laboratory Staff responsibilities)

In addition to being responsible for educational research at the Affiliate Laboratory, Affiliate Laboratory Staff may undertake class and/or research guidance, as long as it does not interfere with the staff's performing of educational research activities in the respective Affiliate Laboratory.

Article 7 (Administrative responsibilities)

The administrative process and work relating to the establishment, etc. of Affiliate Laboratories shall be performed by the Planning and General Affairs Division, Planning and Academic Affairs Department.

Article 8 (Miscellaneous provision)

In addition to the matters stipulated in these regulations, other matters concerning the implementation of Affiliate Laboratories shall be provided for separately.

Supplementary provisions

(Effective date)

1. These Regulations shall come into effect on April 1, 2004.

(Previous Measures)

2. The educational research agreements concluded by the NAIST Graduate School of Information Science and Graduate School of Biological Sciences before the implementation of these regulations shall be deemed as the Agreements of Article 4.

Supplementary provision

These Regulations shall come into effect on November 15, 2006 and be applicable from April 1, 2006.

Supplementary provision

These Regulations shall come into effect on July 26, 2007 and be applicable from April 1, 2007.

Supplementary provision

These Regulations shall come into effect on December 20, 2007.

Supplementary provision

These Regulations shall come into effect on April 1, 2008.

Supplementary provision

These Regulations shall come into effect on April 1, 2009.

Supplementary provision

These Regulations shall come into effect on April 1, 2011.

Supplementary provision

These Regulations shall come into effect on April 1, 2015.

Supplementary provisions

(Effective date)

1. These Regulations shall come into effect on April 1, 2018.

(Abolition)

2. Nara Institute of Science and Technology Collaborative Laboratory Regulations (Regulations No. 13, 2004) shall be abolished.
