Nara Institute of Science and Technology, National University Corporation Fund Regulations

September 20, 2011 Regulations No. 4

Article 1 (Establishment)

The Nara Institute of Science and Technology (hereinafter referred to as "NAIST") shall establish the Nara Institute of Science and Technology Fund (hereinafter referred to as "Fund") in NAIST.

Article 2 (Purpose)

The Fund shall be for the purpose of further promoting NAIST's education and research, societal contributions and international activities, along with improving education and research environments, heading towards the fulfillment of NAIST's role as a world-renowned education and research hub.

Article 3 (Fund projects)

In order to fulfill the purpose stated in the previous Article, the following projects shall be undertaken.

- (1) Projects supporting student academic activities
- (2) Projects supporting international students
- (3) Projects promoting education and research globalization
- (4) Projects for societal collaboration and societal contribution
- (5) Other projects necessary for achieving Fund goals

Article 4 (Fund committee)

- 1. NAIST shall establish the Nara Institute of Science and Technology Fund Committee (hereinafter referred to as "Fund Committee"), consisting of the following members, in order to deliberate the necessary matters concerning the Fund.
- (1) President
- (2) Executive Directors
- (3) Dean of Graduate School
- (4) Each Division Director
- (5) Those persons deemed necessary by the President

- 2. The Fund Committee shall have a chairperson, and the President shall fill this position.
- 3. The chairperson shall preside over the Fund Committee.
- 4. The necessary matters concerning Fund Committee operation shall be stipulated separately.

Article 5 (Fund composition)

The Fund shall be composed of donations from donors and the results of the management of these funds.

Article 6 (Special funds)

- 1. NAIST may establish special funds within the Fund to collect donations for special projects.
- 2. Matters concerning the operation of special funds shall be stipulated separately.

Article 7 (Expression of appreciation)

- 1. The President shall express appreciation to donors
- 2. Necessary matters concerning the expression of appreciation shall be stipulated separately.

Article 8 (Donation acceptance and management)

- 1. The acceptance of donations shall be decided upon following deliberation by the Fund Committee. However, this deliberation may be omitted when so stipulated by the Fund Committee.
- 2. Acceptance of donations and their management shall be regulated in accordance with these regulations and also in accordance with the Nara Institute of Science and Technology Donation Acceptance and Management Regulations and all other related regulations, etc.

Article 9 (Project year)

The Fund project year shall begin on April 1 of every year and end on March 31 of the following year.

Article 10 (Administrative responsibilities)

NAIST shall establish the Nara Institute of Science and Technology Fund Office to be responsible for the administrative duties of the Fund, and the general affairs therein shall be processed by the Planning and General Affairs Division of the Planning and Academic Affairs Department.

Article 11 (Miscellaneous provision)

In addition to the matters stipulated in these regulations, other necessary matters concerning the handling of the Fund shall be provided for separately.

Supplementary provisions

- 1. These Regulations shall come into effect on September 20, 2011.
- 2. Notwithstanding Article 9 of these regulations, the project year for the 2011 fiscal year shall begin on October 1, 2011 and end on March 31, 2012.

Supplementary provision

These Regulations shall come into effect on April 1, 2015.

Supplementary provision

These Regulations shall come into effect on April 1, 2018.
