Nara Institute of Science and Technology, National University Corporation Regulations for Effective Facility Utilization

February 21, 2008 Regulations No. 3

Article 1 (Intent)

These Regulations stipulate the necessary matters in relation to facility use to more effectively utilize facilities and equipment possessed by Nara Institute of Science and Technology (hereinafter referred to as "NAIST") and contribute to invigorating education and research activities.

Article 2 (Definitions)

- 1. "Departments" refers to Graduate School of Science and Technology, Information Initiative Center, Research and Education Center for Genetic Research, Research and Education Center for Materials Science, Data Science Center, Center for Digital Green-innovation, Health Care Center, Institute for Research Initiatives, and Administration Offices.
- 2. "Facilities" refers to buildings possessed by NAIST that are stipulated in Article 3.2 of the Nara Institute of Science and Technology Real Estate Management Regulations (Regulations No. 75, 2004; hereinafter referred to as the "Real Estate Management Regulations"), excluding employee and student housing.
- 3. "Utilization of facilities" refers to conducting investigations and evaluation concerning NAIST's facility use from the perspective of facility management, and effectively utilizing facilities.

Article 3 (Facility use)

- 1. The facility review committee shall conduct facility use in a unified manner.
- 2. From the perspective of facility use, facilities shall be classified into dedicated spaces and spaces for joint use by the entire institute (hereinafter referred to as the "Shared Spaces") that are stipulated in Appendix 1, and the project spaces of Appendix 2 shall be stipulated within the Shared Spaces.
- 3. The head of the Department (hereinafter referred to as the "Department Head") shall operate and manage dedicated spaces.
- 4. Shared Spaces shall in general be of use Institute-wide, they shall be flexibly operated, and the Department Head shall operate and manage them.

Article 4 (Securing shared space)

1. In the event of building new facilities or additional construction to current buildings, Shared Spaces must be secured for at least 20% of the prepared area.

- 2. In the event that repair work will be performed, the Shared Spaces shall be secured in accordance with the content of the work.
- 3. Even in the cases of the two previous clauses, this shall not apply to cases that have been specially allowed by the President.

Article 5 (Burden of expenses)

- 1. The President may have users bear expenses related to the use of project spaces.
- 2. Matters concerning the expenses that will be borne by users under the previous clause shall be stipulated separately.

Article 6 (Investigation of facility use)

- 1. The facility review committee may, regularly or when needed, conduct investigations concerning the actual use of facilities.
- 2. After an investigation of the previous clause has ended, the facility review committee shall promptly create a report on the investigation of facility use (hereinafter referred to as the "Investigation Report") and submit it to the President.

Article 7 (Recommendations for improvement)

- 1. In the event that, based on the Investigation Report, the President has judged that it is necessary to improve space use, he or she may make recommendations to the Department Heads.
- 2. A Department Head who has received a recommendation for improvement under the previous clause shall promptly strive to make improvements and shall report the details to the President.

Article 8 (Administrative matters)

Administrative matters related to effective facility use shall be conducted by the Facility Planning Division of the Operational Affairs Department.

Article 9 (Miscellaneous provisions)

In addition to the matters that are stipulated in these provisions, necessary matters in relation to the operation of these provisions shall be stipulated separately.

Supplementary provision

These Regulations shall come into effect on February 21, 2008.

Supplementary provisions

- 1. These Regulations shall come into effect on February 17, 2009.
- 2. The Nara Institute of Science and Technology Academic-Industrial Collaborative

Facility Management and Operation Regulations (Regulations No. 3, 2005) shall be abolished.

Supplementary provision

These Regulations shall come into effect on June 25, 2009.

Supplementary provision

These Regulations shall come into effect on August 1, 2010.

These Regulations shall come into effect on April 1, 2011.
